### **Everywhere:**

- ON THE INTERNET: Ads for "adult services," chat rooms, video chats, through social media and other websites.
- IN PUBLIC: Minors are taken advantage of through street prostitution or gangs. This can take place at truck stops, tourist attractions, etc.
- **IN PRIVATE:** Homes, apartments, hotels, or motels.
- IN BUSINESSES: Strip clubs, escort services, casinos, sporting arenas, conventions, massage parlors, or spas.

### Understanding the Commercial Sexual Exploitation of Children and Teens



**COMMERCIAL:** Buying or selling

**SEXUAL:** Sex acts

**EXPLOITATION:** Taking advantage of someone



## What is Commercial Sexual Exploitation of Children?

The commercial sexual exploitation of children (CSEC) is when a person buys, sells or trades sexual acts (including pictures or videos) of children and teens under the age of 18 (minors) in exchange for anything of value.

The minor is treated as a commercial and sexual object for profit.

This includes but is not limited to:

- Sexually explicit or abusive videos/ pictures of a minor.
- Selling a minor for sex acts.
- Having sex in exchange for food, clothes, or shelter.

Any minor involved in commercial sex is considered a victim of sex trafficking.



CSEC can happen to anyone of any gender identity no matter what their sexual orientation is.

# How Does Commercial Sexual Exploitation Happen?

### Traffickers target victims to exploit them.

#### Traffickers can be:

- Pimps
- Family
- Partners
- Gangs

Traffickers control youth by making false promises, using threats or violence.

#### <u>Traffickers look for youth who are vulnerable:</u>

- Homeless or in need of basic care
- Have experienced abuse, violence, or neglect
- Are not fitting in or feel isolated

### Multiple people may be involved in recruiting youth for CSEC.

Traffickers search for youth in places such as:

- Online
- Malls
- Parties
- Parks
- Transportation areas

# Laws Protect Minors in Commercial Sexual Exploitation

It is illegal for any adult to be involved in CSEC. In every case of CSEC, the minor is a victim and has the right to protection and services under the law.



Why Does Commercial Sexual Exploitation Happen?

It's hard for many people to understand why this happens. Here are some reasons:

- MONEY: Usually someone profits from the exchange.
- POWER: CSEC is used as a form of control.
  Someone abuses their power over a minor for the benefit of themselves.
- DEMAND: People buy and sell sex. Our society sexualizes young people, and glamorizes violence and pimp culture.
- **UNREPORTED:** Although illegal, CSEC often goes unreported due to fear, shame, or feeling helpless.

There is NO excuse for abuse!
