

STANDARD PHOTO/VIDEO/AUDIO RELEASE FORM

Prevent Child Abuse - New Jersey ("PCA-NJ") is a non-profit organization missioned to eliminate child abuse for New Jersey's children. In consideration that PCA-NJ may use various types footage taken by or on behalf of PCA-NJ, including without limitation, photographs, video footage and audio recordings (the "Footage") to support this mission, and to achieve the goals of PCA-NJ, I grant the following rights to PCA-NJ relating to the use of my name, image, voice and/or likeness in connection with such Footage. If I am signing this Form as the parent or legal guardian of a minor, then the rights granted herein are granted by me on behalf of that minor, and I hereby warrant and covenant to PCA-NJ that I have the right and authority to act on behalf of that minor.

I consent to the use of my name, image, voice or likeness in connection with any and all Footage taken by or on behalf of PCA-NJ, and I further confirm that PCA-NJ, and its affiliates, officers, directors, trustees, employees, agents, successors, assigns, representatives, licensees, and all persons functioning under PCA-NJ's authority (collectively the "Affiliates"), have permission in perpetuity to use, modify, reproduce, distribute and publish the Footage to publicize, promote and market PCA-NJ's non-profit activities and its goals, including without limitation on its web site, and in news articles, publications, press releases, or in any other manner or medium and for any purpose as PCA-NJ or its Affiliates deem necessary. I agree that PCA-NJ shall own all of the Footage and the copyrights therein.

I further agree that I shall receive no compensation in connection with the use of my name, image, voice or likeness in connection with the Footage, as well as the use and distribution of such. I hereby waive any right that I may have to inspect and/or approve the Footage that may be used and or distributed by PCA-NJ or its Affiliates.

I hereby release, discharge and agree to save harmless PCA-NJ and its Affiliates from any liability arising from the breach of any representations or warranties made herein, or arising from the use in any manner of my name, image, voice or likeness including, but in no way limited to any manipulation, blurring, computer imaging, distortion, intentional or otherwise that may be effected in the completion or editing of the Footage, unless it can be shown by me that the publication thereof was malicious and published solely for the purpose of subjecting me to conspicuous public ridicule and scandal.

I represent and warrant that the use of my name, image, voice or likeness in connection with the Footage will not violate the rights of any third party, and will not result in liability for payment by PCA-NJ or its Affiliates to any third party. I further represent and warrant that I have no conflicting advertising or promotional commitments that would cause me to be unable to enter into and fully grant the rights specified by this Release, which I hereby make binding on my heirs, representatives and assigns (and those of any minor on behalf of whom I am signing this release). If any provision set forth herein shall be held illegal, invalid or unenforceable for any reason, the parties shall be deemed to have substituted as part of this Release, in lieu of any such provision or provisions, a clause or provision as similar in terms to such illegal, invalid or unenforceable clause or provision but which shall be legal, valid and enforceable.

I agree that the provisions contained in this Release are reasonable and necessary to protect the legitimate business interests of PCA-NJ, and that the remedy at law for any breach of the foregoing restrictions will be inadequate. Accordingly, in the event of any such breach, PCA-NJ, in addition to any other relief available to it, shall be entitled to preliminary and permanent injunctive relief (without the posting of any bond).
