### ***Domestic Minor Sex Trafficking 101: Overview and Prevention***

**Description:** provides an overview of human trafficking in New Jersey, with a particular emphasis on the commercial sexual exploitation of children.

### ***My Life My Choice Facilitator Training***

**Description:** teaches participants how to use the MLMC curriculum to run psycho-educational groups with vulnerable girls in a variety of settings, while presenting the research behind the MLMC curriculum and exploring potential challenges that may arise. Participants will also receive a copy of the MLMC curriculum as well as membership to the MLMC Online Community. The My Life My Choice Curriculum is a survivor-led, ten-session girl-centered program created to develop and strengthen your efforts to halt the disturbing wave of commercial sexual exploitation and trafficking in the United States.

**CEU:** This course, **My Life My Choice Facilitator Training, Approval #171707-0255**, provided by **Prevent Child Abuse NJ**, is approved for continuing education by the New Jersey Social Work Continuing Education Approval Collaborative, which is administered by NASW-NJ.
