# Master of Ceremonies



**BERT BARON** 

A New Jersey native and lifelong resident, Bert Baron is a New Jersey **Broadcasters Association Radio Hall** of Fame Inductee & award-winning writer, producer & podcaster. Over a career that has spanned more than 25 years in New Jersey, New York and Pennsylvania radio, Bert has garnered a nomination for a prestigious Marconi Award from the National Association of Broadcasters as 'Best Large Market Personality, as well as winning more than a dozen JERSEY Awards from the New Jersey Advertising Club, highlighted by his being honored as "Best of Radio" in 2016.

In July of 2019, Bert successfully segued into the field of local government work to serve as the Public Information Officer for the City of New Brunswick, New Jersey using his decades of media expertise to communicate with local, state and national media as well as overseeing all of the City's online and social media assets. In 2021, while maintaining his position as New Brunswick's PIO, Bert returned to the New Jersey radio airwaves and can be heard weekday mornings from 5:30 to 9 on Northwest Jersey's Own WRNJ and WRNJ.com. Additionally, Bert is the co-host and producer of the B.Inspired podcast and vidcast Series by MRD Productions and also serves as a consultant/ advisor and producer/editor on other special projects including "Mobility Matters" with Keep Middlesex Moving and "TSG Time" with TSG Performance.



### Auctioneer



**CK SWETT** 

CK Swett, a California native and Duke University graduate, began his career in the auction world in 2006 and has worked at Christie's, Phillips, and Heritage.

CK's charity auctioneering efforts since 2010 have yielded more than \$100 million across more than 750 events that support everything from school children in Malawi and veterans returning from Iraq and Afghanistan to public schools in Manhattan and the American Cancer Society.

Hailed by the New York Times as having "managed to shake up the staid world of auctioneering," CK set the world auction record for boxing memorabilia in February 2012, selling the gloves Muhammad Ali wore during his 1965 fight against Floyd Patterson for \$1.1 million on behalf of the Lou Ruvo Center for Brain Health.

Gian Paul Gonzalez is an internationally renowned motivational speaker, nonprofit leader, and youth mentor. Following success as an NCAA First Team All-American forward at Montclair State University, he continued his work with at-risk youth as an educator at Union City High School. He later founded Hope + Future, dedicated to using athletes and physical fitness to share a message of hope and striving for excellence in inner-city public schools and juvenile jails.

Therapist at Center for Counseling Services where he helps
individuals and families recover from the effects of life's traumatic and
toxic stress events. He created Minding Our Children to guide adults

families to heal from emotional hurt, George helps parents, educators,
and other adults understand their work in that healing.
